OPPORTUNITY SCHOLARSHIP FUND

SUPPORTING TUITION ASSISTANCE FOR NEW AND EXISTING STUDENTS WHILE EARNING TAX CREDITS

ANY INDIVIDUAL, FAMILY, OR BUSINESS PAYING TAXES IN OKLAHOMA IS ELIGIBLE TO CONTRIBUTE TO THE OPPORTUNITY SCHOLARSHIP FUND AND RECEIVE GENEROUS TAX CREDITS PLUS A FEDERAL TAX DEDUCTION - WHILE CONTRIBUTING VITAL FUNDS FOR TUITION ASSISTANCE AT CROSSINGS CHRISTIAN SCHOOL.

IN 2011, THE OKLAHOMA LEGISLATURE AUTHORIZED GENEROUS TAX CREDITS FOR INDIVIDUALS, FAMILIES, AND BUSINESSES UP TO \$1,000, \$2,000 AND \$100,000 RESPECTIVELY.

FAQ

Q: WHAT BENEFITS DO I RECEIVE BY DONATING MONEY THROUGH OSF?

A: Your support through the OSF allows you to receive both a federal tax deduction as well as an Oklahoma tax credit for up to 75% of your donation amount. Deductions may vary based upon your tax bracket.

Q: HOW DO I RECEIVE MY DEDUCTION AND CREDITS?

A: It is recommended that you discuss your potential gift with your tax advisor to understand and utilize your full tax savings. Your deduction and credits will be a part of your early tax returns.

Q: HOW DOES MY GIFT SUPPORT CROSSINGS CHRISTIAN SCHOOL?

A: When giving your gift, simply indicate that you support Crossings Christian School and the OSF will reserve over 93% of your gift to support scholarships at CCS students only.

Q: IF I DONATE, CAN I CHOOSE WHICH STUDENTS RECEIVE SCHOLARSHIP?

A: No, scholarships are awarded using the CCS tuition assistance process. Assistance is granted to those who qualify for support and all applicants remain confidential.

Q: DOES MY GIFT TO OSF REPLACE ANY GIFTS I CURRENTLY GIVE TO CCS?

A: No, OSF is designed to redirect your tax dollars with little to no out-of-pocket costs allowing friends and families to continue supporting CCS through our capital campaign, Knightwalk, Annual Golf Tournament, and Annual Fund. These activities allow us to maintain our annual budget and support CCS in ways that the OSF funds cannot.
